Dear student,

Mass Student Testing (Years 12 and 13)

As part of the return to face-to-face education the government is introducing rapid testing of students and staff (who are not displaying coronavirus symptoms) using new quicker COVID-19 tests known as 'lateral flow tests'. Along with the other protective measures we are taking, these tests will help staff and students to remain in school safely. Up to one third of people who have coronavirus experience no symptoms. By testing we will help to stop the virus spreading and help to keep our school open as safely as possible.

We have already established our on-site testing centre which has been in action since January, testing staff and pupils who have been in school. As part of the phased re-opening of schools we will be offering all students **three** onsite tests. After this the government is planning to move to a home testing model (for those who have completed in school testing) and more information about this will be provided at a later date.

Students aged 16 or over are able to give consent, but we would recommend that, before doing so, you discuss this with your parents / carers. **If, on reading this letter and accompanying information, you agree to take part then please follow the link to confirm your consent: <https://tinyurl.com/ymav2yje>.** The link is only available to those with a roundhayschool email account. To enable us to plan for level of demand we would ask you complete this no later than Tuesday 2 March 2021.

The 'lateral flow' tests are quick and easy using a swab of the nose and throat. We expect you to administer the test yourself, but there will be trained staff on hand to assist if required. We have also prepared a video which we hope will reassure you about the process: <https://youtu.be/DUxz8SAT5zl>. This pack also includes a "How to do your test" instructional leaflet from the Department for Education which describes the process, including instructions on how to self-swab.

School staff will register your test with NHS Test and Trace using the information you provide on the consent form. Results will be sent, by the NHS, to the mobile number and email address provided on this form. While these should arrive on the same day (i.e. before midnight), it may not be until much later in the day as tests and results will be uploaded in batches. Examples of the messages used are included in this pack. The school will only contact you in the event of a positive test (see next page).

FREQUENTLY ASKED QUESTIONS

What if I have recently had COVID19?

If an individual has tested positive for COVID19 using a PCR test (those used for those with symptoms) within the past 90 days they are likely to have developed some immunity. However, it cannot be guaranteed that everyone will develop immunity, or how long it will last. It is possible for PCR tests to remain positive for some time after COVID-19 infection. Current guidance says "Anyone who has previously received a positive COVID-19 PCR test result should not be re-tested within 90 days of that test, unless they develop any new symptoms of COVID-19".

What if I test positive?

Participating students who test positive will be informed about their results individually and asked to self-isolate in line with public health guidance. Guidance on safe travel and additional precautions will be provided along with test results. Students may need to take a further 'PCR test' (similar to those done in local and regional testing sites) on the same day (or as soon as possible). Where required Roundhay School will be able to provide these PCR test kits to perform at home or you can go to www.gov.uk/get-coronavirus-test or call 119 to book a follow-up test. If ordering a PCR test yourselves, you should choose to visit a drive-through test site if possible, as it is faster than requesting a home test.

What happens if the test is negative?

Once students have returned to face-to-face lessons they will be able to stay in school and resume their activities as normal. A student will only be contacted by school if they test positive on a 'lateral flow' test, so if you do not hear from us you can assume it was negative. A small number of students may need to repeat the test if the first test was invalid or void for some reason.

What if I do not receive an email or text confirming the outcome of my test?

Unfortunately this is not something we can resolve as we do not have access to the NHS system once data has been submitted. However please be assured that, in the event of a positive or void result, someone will come to find you in school. If this does not happen then you can presume that your result was negative.

What happens if I have been in close contact with someone who tests positive?

Close contacts will be asked to self-isolate immediately for the complete number of days specified by the school. The self-isolation period must be completed in full even if you have received a negative test result yourself.

What if I develop symptoms?

This testing programme at school is for people with no symptoms. If you develop symptoms at any time (such as high temperature; a new, continuous cough; a loss or change to their sense or smell or taste) you must immediately self-isolate, and book a test by calling 119 or visiting <https://www.gov.uk/get-coronavirus-test>







Roundhay School – COVID-19 Testing Privacy Statement

Ownership of the Personal Data

To enable the Covid-19 testing to be completed at Roundhay School, we need to process personal data for staff and pupils taking part, including sharing of personal data where we have a legal obligation. Roundhay School is the Data Controller for the data required for processing the tests and undertaking any actions which are needed by the school / college to ensure we meet our public health and safeguarding legal obligations. Personal data relating to tests for pupils is processed under Section 175 of the Education Act 2002 for maintained schools.

If you decline a test, we record your decision under the legitimate interest of school in order to have a record of your decisions and to reduce unnecessary contact with you regarding testing.

The processing of special category personal data is processed under the provisions Section 9.2(i) of GDPR, where it is in the public interest on Public Health Grounds. This data is processed under the obligations set out in Public Health legislation (Regulations 3(1) and (4) of the Health Service (Control of Patient Information) Regulations 2002 (COPI)) which allows the sharing of data for COVID related purposes and where it is carried out by a health care professional **OR** someone who owes an equivalent duty of confidentiality to that data. For all data that we transfer to the Department for Health and Social Care (DHSC) the Data Controllorship is then passed to them. For more information about what they do with your data please see the Test and Trace [Privacy Notice](#). Roundhay School remains the Data Controller for the data we retain about you.

Personal Data involved in the process

We use the following information to help us manage and process the tests:

- Name
- Unique barcode assigned to each individual test and which will become the primary reference number
- Test result

We will only use information that is collected directly from you specifically for the purpose of the tests, even if you have previously provided us with this information.

When you register in advance of your test, you will be required to provide the following information which will be used by Department for Health and Social Care (DHSC).

- Gender
- Ethnicity
- Home postcode
- Email address
- Mobile number

Data Controllorship is then passed to the Department for Health and Social Care (DHSC) for this and all data that we transfer about you and your test results. For more information about what they do with your data please see the Test and Trace [Privacy Notice](#).

How we store your personal information

The information will only be stored securely on local spreadsheets at Roundhay School whilst it is needed. It will also be entered directly onto DHSC digital services for the NHS Test and Trace purposes. Roundhay School will not have access to the information on the digital service once it has been entered.

Processing of Personal Data Relating to Positive test results

You will be informed of the result by Roundhay School and may be advised how to book a confirmatory test.

We will use this information to enact our own COVID isolation processes without telling any unauthorised person who it is that has received the positive test.

The information will be transferred to DHSC, who will share this with the NHS, GPs, PHE and the Local Government will use this information for wider test and trace activities as well as statistical and research purposes.

This information is processed and shared under obligations set out in Public Health legislation under Regulations 3(1) and (4) of the Health Service (Control of Patient Information) Regulations 2002 (COPI) which allows the sharing of data for COVID related purposes.

This information will be kept by Roundhay School for a minimum of 14 days and securely destroyed within 1 month of the testing programme ending; and by the NHS for 8 years.

Processing of Personal Data Relating to Negative test results

We will record a negative result and the information transferred to DHSC, NHS, PHE and the Local Government who will use the information for statistical and research purposes.

This information is processed and shared under obligations set out in Public Health legislation under Regulations 3(1) and (4) of the Health Service (Control of Patient Information) Regulations 2002 (COPI) which allows the sharing of data for COVID related purposes.

This information will be kept by Roundhay School for a minimum of 14 days and securely destroyed within 1 month of the testing programme ending; and by the NHS for 8 years.

Processing of Personal Data relating to declining a test

We will record that you have declined to participate in a test and this information will not be shared with any unauthorised person.

Data Sharing Partners

The personal data associated with test results will be shared with:

- DHSC, NHS, PHE – to ensure that they can undertake the necessary Test and Trace activities and to conduct research and compile statistic about Coronavirus.
- Your GP – to maintain your medical records and to offer support and guidance as necessary.
- Local Government to undertake local public health duties and to record and analyse local spreads.

Your Rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
